- D. Liquefied petroleum gas should be not stored in the building.
- E. The doors shall not be kept locked/latched during working hours and shall be free from obstruction.
- F. During the class hours the class room doors shall not be locked from inside to outside.
- G. As per Hon'ble Supreme Court order all teacher and staff shall be trained to handle safety equipment, initiate emergency evacuation and protect their students in the event of fire and other emergency and the school shall observe the Fire Safety day on April 14th of every year by conducting fire safety drills with coordinate with Fire Service Department.
- H. This Fire Safety Recommendation is issued from the fire prevention, fire fighting and evacuation measures. Karnataka State Fire & Emergency Services Department is not responsible for the ownership of the land, its location and other disputes, which may arise in due course.
